

## CONTEST RULES

### “A night at the symphony”

#### **CONTEST RULES (hereinafter called the “Rules”)**

The “A night at the symphony” contest (hereinafter called the “Contest”) is organized by the Orchestre Métropolitain de Montréal (hereinafter called the “Organizer”). The Contest runs from January 15, 2024 11:30 a.m. (EST) to January 28, 2024 at 11:59 p.m. (EST) (hereinafter called the “Contest Period”).

#### **ELIGIBILITY**

The Contest is open to all Quebec residents who have reached the age of majority based on their province or territory of residence at the time of entry. Exemptions apply to employees, agents and representatives of the Organizer along with any other party directly involved in the Contest operations, including members of their immediate families (any parents, brothers, sisters, children, legal or common-law spouses and all persons living with such employees, agents, representatives and other members.) ONLY ELIGIBLE PARTICIPANTS NEED ENTER.

#### **HOW TO ENTER**
